#### **Call for Papers**

Researchers, academicians, sociologist, economists, environmentalists, social workers, government employees, private sector employees, policy makers and other stakeholders are welcome to submit their original research papers on any of the sub-themes of the conference described below.

- Environment, Public Health and Transport;

- Road, planning design and development;
- Common and different responsibility and liability of Stakeholder;
- Transport, Public Awareness and Role of electronic and print Media, NGOs and social media.
- Social awareness of road safety measures
- Inclusion of traffic rules as part of primary education
- Training of stakeholders of public transport sector
- Coordination between different stakeholders in public transport sector

#### **Abstract Submission**

We are inviting interested researchers to send us an abstract of an original research paper (within 300-500 words) to [bilia222.info@gmail.com](mailto:bilia222.info@gmail.com) The abstract should be accompanied by a short biography including the author’s full name, date of birth and academic/professional affiliation and list of publications (if any).

Subject head of the email should include “Abstract submission for the conference, “Transport, Law and Policy”.

The deadline for submission of abstracts is **November 30, 2018**.

**Abstracts selected for the conference will be notified by 7<sup>th</sup> December, 2018.**

The deadline for submission of the full paper is **December 20<sup>th</sup>, 2018**.

The selected presenters would have to register on or before the final registration deadline. All papers submitted for the conference will be peer reviewed and selected based on merit for publication in the forthcoming Bangladesh Journal Law (BJL) Vol. 19 (2019). The paper should also maintain the reference style of the BJL which, along with other details, will be sent to the authors once their abstracts are selected for presenting in the conference.

### **Conference Registration**

In addition to the submission of abstracts BILIA is also inviting participants from young researchers groups as discussants/observers at the conference. However, the number of participants is limited and prior registration is required for participation.
